The above stated intentions will be carried out in the manner applied for in accordance with plans, specifications, map and statements filed with the City of Northville as part of this application, and if said permit is granted, the above named applicant agrees to do the following

1. Give written notice to the Public Works Director at least three (3) days prior to commencement of operations covered by this permit.
2. In any and all operations under this permit, meet all requirements of the City of Northville Standard Specifications; and additional conditions set forth on this applications and permit.
3. Take, provide and maintain all necessary precautions to prevent injury or damage to persons and property from operations covered by this permit and use safety devices which are approved by the City of Northville.
4. Save harmless the City of Northville against any and all claims for damages arising from operations covered by this permit and furnish a copy of insurance coverage naming the City of Northville as an additional insured party for the term of this permit for \$500,000. personal injury and \$500,000. property damage and workman's compensation for operations covered by this permit. "The policy shall contain a termination notice requiring the City of Northville to be notified in writing no less than 30 days before termination of the policy of insurance."

5. Surrender the permit herein applied for, cease operations, and surrender all rights hereunder whenever notified to do so by the Director of Public Works because of his need for the area covered by the permit, or because of a default in any of the conditions of the permit. The applicant hereby expressly waives any right to claim damages or compensation in case this permit is revoked.
6. Upon request, file a bond and or cash deposit in the sum of \_\_\_\_\_ acceptable to the Director of Public Works and conditioned upon performance of the conditions of the permit and compliance with all requirements of law.
7. Permit - The foreman in charge of the work shall have the permit and the approved plans or sketches in his possession on the job at all times.
8. Inspection - In all cases the applicant shall notify the City of Northville, 48 hours before the work will commence , so arrangements may be made to have an inspector present while the work is in progress. The applicant will post a cash deposit for necessary expense of the inspector and stand-by D.P.W. crew with the balance to be returned on completion of work.
9. Any operation in the right-of-way not covered by the above, specifications submitted with this permit, or the City of Northville Standard Specification, shall be done in accordance with instruction of the Director of Public Works.
10. Tree Trimming or Tree Removal - In manner to be prescribed by the Director of Public Works (trimming)and as prescribed by the City's Tree Ordinance.
11. Full compliance is required with any regulations of the Public Service Commission.
