### PRESENTATION BY CARLISLE/WORTMAN ASSOCIATES

Don Wortman, the City of Northville Planning Consultant, presented the City of Northville Non-Motorized Plan and the City of Northville 2014 Master Plan Update.

The City of Northville Non-Motorized Plan was created by a committee comprised of: Ken Roth/Northville Public Schools; Jennifer Fry/Northville Township; Pat Sullivan/City of Northville, City Manager; Jerry Mittman/Resident; Michelle Aniol/Resident; Patrick Geisa/Resident; Paul Lamoureaux/Resident; Elizabeth Iszler/Wayne County Parks; Jim Gallogly/City of Northville Public Works Director; Jason Spiller/Northville Parks and Recreation Director; and Lori Ward/Northville DDA Director.

Non-motorized pathways have become major assets for communities. Non-motorized pathways include bicycles, pedestrian, and handicap pathways. Northville is uniquely situated between the Wayne County Hines Park and the State of Michigan's Maybury State Park. The Plan was created to identify the opportunities, and the types of trails that can we created to connect these regional assets. Additionally, non-motorized pathways bring benefits to the Downtown, Mill Race Village and Ford Field. The Committee has been meeting for approximately six months. The presentation will go before the Planning Commission and the City Council, for approval.

The City of Northville 2014 Master Plan Update Committee is comprised of: Jay Wendt/Planning Commission; Dave Mielock/Planning Commission; Sarah Traxler/Planning Commission; John Casey/Northville DDA; Shawn Riley/Northville DDA; Greg Presley/Northville DDA; Dan Ferrara/Northville Central Business Association; Joe Hoffman/Historic District Commission; John Argenta/Historic District Commission; Ken Roth/Northville Board of Education; Joe Hige/Northville Board of Education; Michelle Aniol/City of Northville Resident.

The City of Northville Master Plan is scheduled to be updated in 2014. Areas available for redevelopment include: Northville Downs; West Main Street and the school property which is no longer occupied; the Post Office site; and the CadyTown area. The purpose of this Plan is to determine the vision for each of these entities, as they each have their own unique situations. When determining what the vision should look like, the following resources were reviewed: The original Master Plan; the 2008 Update; the market analysis from the DDA; the flood plain within the City boundaries. To this end, it was determined that any new developments within the Downtown must contain the following: pedestrian friendly characteristic; complimentary to and support the existing business community; the architecture and design must be high-quality; new developments must be economically feasible and market based for the particular areas.

#### COMMITTEE APPOINTMENTS

The DDA has retained professional consultants for Wayfinding and Exhibit Design projects, both projects are scheduled to begin site visits and design implementation in February. Bizzell Design, from North Carolina, was selected from ten proposal submissions, to develop a comprehensive Wayfinding and Signage program for Downtown Northville. Experience Design, from Boston, was chosen from 14 proposal submissions, to create an interpretive design installation, representative of the Northville Community, for the Comerica Community Connection in Downtown Northville.

The Wayfinding Committee formed to review the RFPs and interview the candidates consisted of: John Argenta, Carol Maise, Joan Potter Thomas, Alan Somershoe, Jim Gallogly, Greg Presley and DDA staff.

The Exhibit Design Committee formed to review the RFP and interview candidates consisted of: Michelle Fecht, Heidi Neilsen, Joan Potter Thomas, Alan Somershoe, Lynda Heaton, Mary Starring, and DDA staff.

DDA staff asked that the DDA Board of Directors appoint John Argenta, Carol Maise, Joan Potter Thomas, Alan Somershoe, Jim Gallogly, and Greg Presley to serve as the "Steering Committee" for the Wayfinding project.

DDA staff asked that the DDA Board of Directors appoint Michelle Fecht, Heidi Neilsen, Joan Potter Thomas, Alan Somershoe, Lynda Heaton, and Mary Starring to serve as the "Steering Committee" for the Exhibit Design project.

**Motion by Johnson, seconded by Riley**, to approve the DDA proposed Steering Committee members for both the Wayfinding project and the Exhibit Design project. **Motion carried unanimously**.
