Discussion ensued pertaining to the State-mandated training requirement for poll workers, poll workers that cannot attend training but are available to work on Election Day, and the need to find enough poll workers to sufficiently staff the polling places. The City is having difficulty finding poll workers, and some of the poll workers are not able to make the Oakland County training sessions. The Clerk is looking for alternate training sessions in Novi. Record voter turnout is expected. Concern was voiced with appointing inspectors that did not attend statemandated training. Poll workers should be strongly encouraged to attend training.

**Motion Giesa seconded by Marzano** to appoint the above inspectors as the Election Inspectors and Receiving Board for the November 6, 2018 General Election. Further, the City Clerk is authorized to make emergency appointments as necessary to ensure sufficient staffing at each precinct. **Motion carried unanimously.**
